Justification:

- The increase in physical target/decrease in unit cost of CW1: Off-Carriageway Improvement Paving of Shoulders is due to the following:
 - Increase in the shoulder width from 1.25m to 2.50m which resulted in the increase of target area from 1,961.25 0 square meters to 3,093.25 square meters.
 - The unit cost of Off-Carriageway Improvement: Paving of Shoulders as per GAA is sufficient to accommodate the 0 increase the physical target of the project, consequently decreasing the unit cost as per the Department Standard Unit Cost.
- The change in the project limits is due to the prioritization of sections needing Off-Carriageway Improvement: Paving of Shoulders. (Please see attached Straight Line Diagram.)

- The unit cost of RROW was based on the zonal value established for Barangay Sinsayon, Santiago City, Isabela, as stated in the database for zonal values provided by the Bureau of Internal Revenue. (See attached Zonal Values.)
