Modification is sought due to:

- 1. Change in road section ID to conform with the Roads and Bridge Information Application (RBIA).
- 2. The increase in unit cost is due to the inclusion of Structure Excavation (Common Soil), Embankment from Roadway Excavation (Common Soil) and Embankment form Borrow (Common Soil) resulting to the decrease in physical target from 2,400 square meters to 1,999.10 square meters.
