Justification:

• Change in size of the drainage structure in the original proposal from 1.2m x 1.2m RCBC to 0.9m x 1.3m lined canal drainage due to the presence of obstructions in the project location, therefore there is decrease in unit cost.

- The project location requires additional length for the drainage structure, hence, the increase in physical target.
- The change in the project title was made to state/include the actual limits in the project title to clearly delineate the start and end limits of the project, and synchronize with the increase in the physical target.
