Justification:

The project is to be modified in view of the following:

- The decrease in the unit cost is based on validated and approved Detailed Unit Price Analysis (DUPA) and Program of Work (POW).
- Deletion of station K0340+960 due to its duplication in same project.
- The increase in physical target is due to the lengthening of the cross-drainage canals as requested by the
 affected land owners and as validated by the Planning and Design Engineers within the catchment area to
 prevent damages caused by water runoff and flooding especially during rainy season.
- The completion of the project will effectively and safely convey water runoff to avoid damages along national roads.

Attached are the following supporting documents: Approved Program of Works (POW) with Detailed Unit Price Analysis (DUPA), Detailed Engineering Design (DED), Certificate of Availability of Funds (CAF), BP 202, Geotagged photos, GIS Map and Certification of No overlapping (Certified by the District Engineer, Planning & Design, Construction and Maintenance Division Chief).
