This section was severely damaged by continuous downpour of heavy rain wherein this road cut section is already in dire condition that is prone to accident and needs urgency to be addressed. Hence, the allocation of this project will be allotted for the restoration of road cut.
- Increase in the physical target is due to additional upslope protection required to fully stabilize the road.
- Decrease in the computed unit cost based on validated and approved DUPA and POW.
