

Justifications provided by the requesting Implementing Office:

- 1. The allocation of P 1.874 Million is insufficient to cover the total cost of the original physical target, hence, adjustment in station limits is requested to prioritize section that needs asphalt overlay (4 lanes) to prevent further deterioration of pavement for the safety of the travelling public.
- 2. The decrease in physical from 0.136 Lane Km to 0.108 Lane Km and consequently increase in unit cost to P 16,744,537.04 per Lane Km was due the revised cost of construction materials based on updated canvassed prices.
- 3.
