Justifications based on the attachments submitted by the Implementing Office:

1. Change in station limits to avoid overlapping of project funded under FY 2024 GAA with Project ID: P00801179VS and to include prioritize road section that are in bad condition that needs immediate concrete reconstruction to address the deterioration/degradation of the pavement for the safety of the travelling public.

2. Based on the plan and actual site condition, the project involves concrete reconstruction with 300mm slab including miscellaneous structures such as application of reflectorized thermoplastic pavement markings, rumble strips and installation of Solar LED Roadway Lighting. The increase in unit cost was due to the hauling cost of construction materials (sand and gravel) due to unavailability of source in the vicinity of 1^{st} District of Samar.
