1. Adjustment in station limits to avoid overlapping to the adjacent asphalt overlap projects,

 Increase in unit cost per lane km of CW1 based from the 4th Quarter Construction Material Price Data (CMPD) in pursuant to DO 23 s. 2023: Guidelines for the Utilization of the Prices of Construction Materials and Equipment Rental Rates for Various Infrastructure Projects which resulted to decrease in physical target from 11.312 lane km to 10.64 lane km
