Guindapunan, Catbalogan City, Samar, of the project under FY 2024 General Appropriation Act (GAA), to wit;

Justifications based on the attachments submitted by the Implementing Office:

- Change in station limits to (1) omit road sections that doesn't require immediate reconstruction, and (2) include and prioritize road segments that needs concrete reconstruction due to bad condition (see attached straight line diagram), maximizing/utilizing the allotted amount, with an equivalent increased physical target from **2.15 Lane Km** to **2.97 Lane Km** for safer, reliable and faster transportation of goods, people and services.
- Based on the plan and actual site condition, the project involves reconstruction to concrete pavement which includes roadway lighting (Single Arm Solar LED, 8-m Pole, 60W-80W, not exceeding 10% of the total construction cost), earthworks and other essential items needed for the implementation of the project, attaining the unit cost of **P11,548,821.55 / Lane Km**.

Attached are the following supporting documents: Form for Evaluation of Modification Request, BP 202, Certificate of Availability of Funds, Approved Program of Works, Plan, Geotagged Photos, Certificate of Reasonableness of Cost Estimate, Straight Line Diagram and Location Map.
