Justification:					

- The decrease in unit cost/ increase in the physical target of CW1 Preventive Maintenance of Road: Asphalt Overlay from 17.134 lane km to 18.858 lane km due to the following:
 - The inclusion of outer lanes and shoulders for asphalt overlay in the scope of work, to level the entire carriageway and shoulder and will improve road safety.
 - The allocation for asphalt with corrections as per GAA is sufficient to cover the entire station limits provided, based on the Department Standard Unit Cost.
- The unit cost is based on the validated and approved Detailed Engineering Design (DED), Detailed Unit Price Analysis (DUPA), and Program of Work (POW). The unit prices used are based on approved Construction Materials Price Data (CMPD) for the 4th Quarter of CY2023
