

Justification:

- The decrease in the physical target / increase in the unit cost of CW1 – Preventive Maintenance of Road: Asphalt Overlay with Correction from 6.349 lane-km to 3.058 lane-km is due to:
 - Inclusion of hydrated lime to provide resistance to rutting and fatigue cracking on items 310(1) c Bituminous Concrete Surface Wearing Course, Hot-Laid 50 mm and 310(2) c Bituminous Concrete Surface Binder Course, Hot-Laid 50 mm.
 - Consideration of Paved shoulders along the new project's limits.
- Furthermore, the unit cost has been evaluated and reviewed by the Bureau of Construction (BOC) dated May 22, 2024. (Please see attached copy)
- The change in total amount of the project was reduced from Php 55,326,000.00 to Php 55,291,056.59 as the result of the evaluation on the construction cost of the project by the Bureau of Construction dated May 22, 2024 (see attached). Hence, there is an excess amount of Php 34,943.41.
- The change in the station limits is due to prioritizing sections necessitating preventive maintenance measures identified through visual assessments. (Please see attached Straight-Line Diagram and Geotagged Photos)
