Justification:					

- The increase in the unit cost/decrease in the physical target of CW1 Preventive Maintenance of Road: Asphalt Overlay with Correction from 14.056 lane-km to 9.046 lane-km is due to:
 - The additional work of re-blocking the deteriorated PCCP with base failure on the main carriageway, which if not corrected will cause failure in the new asphalt overlay.
 - The adjustment of asphalt overlay thickness from 50 mm to 100 mm for better strength and weightresistance.
- The change in the station limits was made to prioritize sections necessitating preventive maintenance measures and to synchronize with the decrease in physical target. (Please see attached Straight Line Diagram.)

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).
