Justification:

- The increase in unit cost/decrease in physical targetis due to the increase in thickness of the main PCCP and shoulder pavement from 230mm to 300mm following the prescribed design standards based on DO 40, S 2014 and provision of reinforced PCCP on sinking sections at K0283+(-463)-K0283+073 and K0284+365 -K0285+988 to provide additional structural support, addressing the instability of the base.(please see attached DO)
- Change in station limits is due to exclusion of sections K0283+073 K0284+365 that were reconstructed under FY2022 GAA and still in good condition. (please see attached straight line diagram and FY 2022 AIP based on GAA).
