## Justification:

- The increase in physical target/decrease in unit cost is due to the validated cost of Item 310 Bituminous Concrete Surface Wearing Course, Hot Laid with a thickness of 100mm (50mm per layer) which constitutes 98.26% (₱ 142,231,089.65) of the total project cost.
- The changed in the station limits was made to synchronize with the increase in the physical target and to consider road segments along the road section that are currently in fair condition based on the FY 2022 RoCond data. See attached Straight Line Diagram.
- The derived unit cost is based on the approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
