Modification is sought due to:

- 1. Adjustment in station limits to provide continuity of sections with asphalt overlay and to remove the (with exception) in the project name since the scope of work will cover the whole station limits.
- Increase in unit cost per lane km of CW1 based from the 4th Quarter Construction Material Price Data (CMPD) in pursuant to DO 148 s. 2023: Guidelines for the Utilization of the Prices of Construction Materials and Equipment Rental Rates for Various Infrastructure Projects which resulted to decrease in physical target from 5.878 lane km to 5.36 lane km
- Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, Certification for Reasonableness of Cost dated February 5, 2024.
