Justification:

- The change in station limits is undertaken due to the overlapping with the project under GAA 2024 which is identified by Project ID No. P00803767MN. Specifically, this project overlaps with the station limits from K1527 + 0000 - K1527 + 520.
- The modification of the original station limits from K1538+1014 to K1539+000 is attributed to the updated stationing data obtained from the 2023 Official Rocond Survey.
- Aside from overlaying the 4-lane carriageway with 50mm thick asphalt, the project also includes:
 - The provision of a 0.3-meter transition width on both sides of the outermost lanes to the shoulder throughout the entire project limits, to facilitate a smooth transition and enhance overall road safety and functionality.
 - The reconstruction of existing concrete pavement along sections with shattered slabs before the asphalt overlaying.
 - 3. Provision of Reflectorized Pavement Markings to enhance road safety.
- The derived unit cost is based on the approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
