Justification: <ul style="list-style-type: none">The increase in unit cost/decrease in the physical target of CW1 – Preventive Maintenance of Road from 6.128 lane km to 3.604 lane km is due to the following:<ul style="list-style-type: none">The unit cost of asphalt overlay with correction as per GAA cannot cover the entire station limits provided, based on the Department Standard Unit Cost.Asphalt overlay includes paving of shoulders on both sides to address road safety concerns.Need for re-blocking on some dilapidated segments at K0309 + 000 – K0309 + 828 of carriageway (PCCP) with 300mm thick and the inclusion of item 206 (1) Polymer Stabilized Sub-base/ Base/ Surface Course as base stabilizer prior to asphalt overlay.Increase width of carriageway modified from 3.35m to 3.50m to conform to the lane configuration width as per Memorandum dated October 23, 2023 (Typical Standard Plans for Maharlika Highway).Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of “No Overlapping” and “Not Within Warranty Period”, Geotagged Photographs, Approved Program of Works (POW), Approved Detailed Engineering Design (DED) and Design Analysis of Asphalt Overlay
