#### Justification:

The decrease in the unit cost is attributed to the exclusion of drainage work from the original scope. It was done since certain sections already have existing drainage structures, and other sections without drainage structures are encountering right-of-way (ROW) issues.

The decrease in the physical target of CW1 - Rehabilitation of Paved Road from 6.544 lane km to 5.579 lane km is due to the absence of available bad sections, as determined by the actual survey. As a result, CW2 - Preventive Maintenance: Asphalt Overlay has been introduced to effectively utilize the remaining

budget, aside from this approach is a more cost-effective method, as it prevents the deterioration of the existing PCCP, rather than rehabilitating sections that are currently in fair condition.

- The introduction of CW2 Preventive Maintenance: Asphalt Overlay, which comprises 37.87% of the project budget allocation, involves 100mm thk asphalt overlay on carriageway with a width ranging from 3.35m to 3.50m (1-4 lanes) including shoulder with a width ranging from 1.2m to 2.7m.
- There is change in the station limits since the original sections exhibit fair to good condition, as per RBIA and actual inspection. Therefore, the project limits are relocated to prioritize sections necessitating rehabilitation of paved road and asphalt overlay identified through actual survey. (Please see attached Straight-Line Diagram and Geotagged Photos)

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
