- Change in station limits from K0535+680 – K0535+753 to K0546+178.81 – K0546+425.98 is due to immediate need to address the massive scouring/erosion on the roadside of the modified sections which is dangerous for the end users. (Please see geotagged photos and Straight Line Diagram/SLD.)
