Justification:

Change in the major scope of works, from "Pavement Markings" to "Roadway Lighting", is deemed necessary to
address the urgent need to increase road illumination and visibility to promote enhanced safety, security and
convenience for both the pedestrians and motorists.

 Additional scope of work "Road Safety: Traffic Signals" is desired to ensure orderly flow of traffic and to provide an opportunity for pedestrians or vehicles to cross the critical intersections safety and help reduce the number of conflicts between vehicles coming from different directions.

 The revised physical target is based on aligning the major scope of work with accordance to the Standard Target Definitions.

 See attached Certificate of Reasonableness of Cost Estimate signed and approved by the Regional Director, and the results of evaluation conducted by Bureau of Construction last April 18, 2024. Based on our evaluation, the submitted request for project modification is in order, hence, it is respectfully recommended to the Secretary for his consideration and approval.
