### **Justification:**

.

 The increase in physical target/decrease in unit cost of CW1: Rehabilitation of Paved Road from 3.576 lane km to 4.800 lane km is due to the following:

- Exclusion of CW2: Road Widening to prioritize the main civil work component, CW1: Rehabilitation of Paved Road, hence the inclusion of additional bad/poor sections needing rehabilitation of paved roads were considered, consequently increasing its physical target.
- Change in the thickness of item 201 (1) Aggregate Base Course from 200mm to 100mm thick, due to the presence of 250mm thick Polymer Stabilized as base course.

The change in station limits is due to the reason that the original project limits overlap another project, concurrently prioritizing the section needing Rehabilitation of Paved Road to synchronize with the increase in the physical target. *(Please see geo-tagged photos and Straight Line Diagram.)*
