The change in the scope of work from CW1 - Road Safety: Pavement markings to CW1 - Road Safety: Roadway Lighting is a result of a conducted survey, showing a recent application of pavement markings and now requiring roadway lighting and the provision of traffic signages at the modified station limit. (Please see attached Straight Line Diagram)

The change in the station limits from K0252 + 272 - K0253 + 270 to K0252 + 002 - K0253 + 000 is due to an overlap with asphalt reconstruction with complete roadway features along station limits K0253 + 000 - K0255 + 766 under 2024 projects.

The unit cost has been evaluated and reviewed by the Bureau of Construction (BOC). See attached evaluation dated May 14, 2024.
