Justification:

• The minimal increase in the unit cost/decrease in the physical target from 1,000 to 958 lineal meters is due to the inclusion of item 605 (5) b1 Traffic Instruction Signs 1500mm x750mm S2-1 Movement Instruction Signs Reduce Speed to address pedestrian safety concerns.

• The change in the station limit is due to the overlapping of Rehabilitation/Reconstruction project with complete roadway features along K0325 + 000 - K0326 + 537 under GAA 2024. (Please see attached Straight Line Diagram)
