



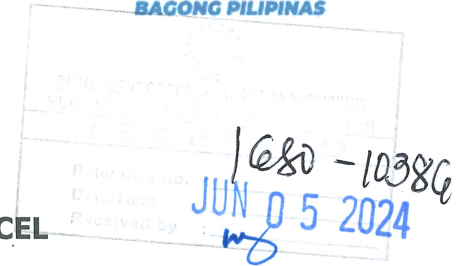

<b>Justification:</b> <ul style="list-style-type: none"><li>The decrease in the unit cost/increase in the physical target from 1,009 to 1714 lineal meters is based on the validated and approved Detailed Unit Price Analysis (DUPA) and Program of Works (POW), and also a result of the actual survey, revealing a surplus of traffic signages in the area, hence the reduction of proposed traffic signages.</li><li>The change in the station limit is due to the overlapping of Rehabilitation/Reconstruction/Upgrading of Damaged Paved Roads project with complete roadway features along K0266 + (-008) – K0266 + 570, K0266 + 595 – K0267 + 298, K0267 + 312 – K0269 + 005 under GAA 2024, concurrently prioritizing the section needing Road Safety: Pavement Markings. <i>(Please see attached Straight-Line Diagram)</i></li></ul> <p>Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of “No Overlapping” and “Not Within Warranty Period”, Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).</p>
