Justification:	Justification:					

The decrease in physical target for CW1 – Construction of Gravel Road from 16.038 lane kilometers to 6.858 lane kilometers and increase in the unit cost are due to the following:

- During the validation, the end-users requested that instead of constructing the road around the mountain, tunneling (located around 5.66 km from the start of the road and is estimated to be about 120 m in length) will be introduced which will run through the mountain. Furthermore, it was agreed upon by the end-users and LGU that the opening of road will be prioritized, and that they will find another source of fund for the tunneling. Due to this, the physical target decreased.
- The gabion structures will serve as containment wall for the excavated materials and the slope protection structures will help prevent soil erosion along sections that has very steep slopes.
- The provisions of RCPC (Type II) is deemed necessary in order to properly address/convey the water run-off during rainy season to its natural waterway. This will help prevent water accumulation and protect the open road from scouring.
- The increase in the unit cost is attributed to the massive earthwork, 20,475.30 cu.m soft rock, 107,236.40 cu.m. hard rock, 31,166 cu.m. common earth and embankment of 22,863.50 cu.m. Another factor contributing to this increase is the necessity to construct gabion structure at the identified disposal sites for the excavated materials, and to provide slope protection structures along sections that has very steep slopes.

The estimated cost of **P21,129,338.19** per lane kilometer is due to the design requirements as reflected in the approved design considering the appropriate Pay Items under Parts C, D, F, G and H. The said unit cost per lane kilometer includes provision of 31,166.00 cubic meter of surplus common excavation, 20,475.30 cubic meter of surplus rock excavation (soft), 107,236.40 cubic meter of surplus rock excavation (hard), and 22,863.50 cubic meter of embankment from roadway excavation, which accounts to **88.374%** of the total construction cost. Hence, it is considered reasonable as the Unit Costs of the items of work involved are within the range of the prevailing cost of the Department.

The estimated cost of **P23,207,824.47** per lane kilometer is due to the design requirements as reflected in the approved design considering the appropriate Pay Items under Parts C, D, G and H. The said unit cost per lane kilometer includes provision of 3,688.50 cubic meter of surplus common excavation, 21,031.00 cubic meter of surplus rock excavation (soft), 121,363.30 cubic meter of surplus rock excavation (hard), and 2,526.20 cubic meter of embankment from roadway excavation, which accounts to **91.014%** of the total construction cost. Hence, it is considered reasonable as the Unit Costs of the items of work involved are within the range of the prevailing cost of the Department.

32. TECHNICAL JUSTIFICATION (Explain in detail in Bullet point format; minimum of 2 points)

The decrease in physical target for CW1 – Construction of Gravel Road from 16.938 lane kilometers to 6.858 lane kilometers and increase in the unit cost are due to the following:

- During the validation, the end-users requested that instead of constructing the road around the mountain, tunneling (located around 5.66 km from the start of the road and is estimated to be about 120 m in length) will be introduced which will run through the mountain. Furthermore, it was agreed upon by the end-users and LGU that the opening of road will be prioritized, and that they will find another source of fund for the tunneling. Due to this, the physical target decreased.
- The gabion structures will serve as containment wall for the excavated materials and the slope protection structures will help prevent soil erosion along sections that has very steep slopes.
- The provisions of RCPC (Type II) is deemed necessary in order to properly address/convey the water run-off during rainy season to its natural waterway. This will help prevent water accumulation and protect the open road from scouring.
- The increase in the unit cost is attributed to the massive earthwork, 20,475.30 cu.m soft rock, 107,236.40 cu.m. hard rock, 31,166 cu.m. common earth and embankment of 22,863.50 cu.m. Another factor contributing to this increase is the necessity to construct gabion structure at the identified disposal sites for the excavated materials, and to provide slope protection structures along sections that has very steep slopes.
- The derived unit cost is based on the approved Program of Work (POW) with Detailed Unit Price Analysis (DUPA).
- See attached Certificate of Reasonableness of Estimates approved by the Regional Director.
- The unit cost has been evaluated and reviewed by the Bureau of Construction (BOC). See attached evaluation dated June 07, 2024.
