



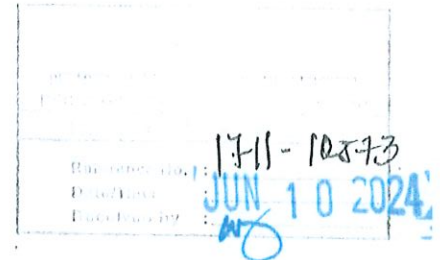

<ul style="list-style-type: none">The decrease in unit cost/ increase in the physical target of CW1 – Construction of Concrete Road from 0.636 lane km to 1.780 lane km is due to the following:<ul style="list-style-type: none">The project consists of 6.10m wide with 280m thickness PCCP and 610mm diameter Reinforced Concrete Pipe Culvert (Cross Drain) with 1.2m x 0.9m Catch Basin.Minimal embankment and slope protection is needed due to flat terrain.Exclusion of gravel shoulder on both sides due to right of way constraint.Additional length was considered to maximize the utilization of the allotted budget.
