Justification:

- The decrease in unit cost/ increase in the physical target of CW1 Construction of Concrete Road with physical target from 0.574 lane km to 1.396 lane km due to the following:
 - o Minimal embankment is needed due to flat terrain.
 - Road features such as drainage structures and slope protection are not utilized on the entire road section due to flat terrain.
 - Decrease in the thickness of unreinforced PCCP from 280mm thick to 230mm to align with the current road thickness.
- Additional length was considered to maximize the utilization of the allotted budget.

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).
