- The decrease in unit cost/ increase in the physical target of CW1 Construction of Concrete Road from 0.848 lane km to 1.766 lane km is due to the following:
 - The project consists of 6.10m wide with 280mm thick PCCP and 1.0m width concrete shoulder with 230mm thickness.
 - Minimal embankment and road feature such as drainage structure is not included in the Detailed Engineering Design due to flat terrain.
 - Additional length is considered to maximize the utilization of the allotted budget.
- The inclusion of CW2: Construction of Road Slope Protection, which accounts to 11.12% of the total cost, to address road safety concerns by ensuring slope stability to prevent soil erosion.
