

- The decrease in unit cost/ increase in the physical target of CW1 Construction of Concrete Road with physical target from 0,620 lane km to 1,646 lane km due to the following:
 - Minimal embankment is needed due to flat terrain.
 - Road features such as drainage structures and slope protection are not utilized on the entire road section due to flat terrain.
 - Decrease in the thickness of unreinforced PCCP from 280mm thick to 230mm to align with the current road thickness.
- Additional length was considered to maximize the utilization of the allotted budget.
- The derived unit cost is based on validated and approved detailed engineering design (DED), detailed unit price analysis DUPA) and program of work (POW).
