Justification:

- The decrease in the physical target / increase in the unit cost of CW1 Asphalt Overlay with correction from 2.122 lane-km to 1.830 lane-km is due to:
 - o The project will utilize 80mm thk Asphalt Overlay (2-layer/40mm thick) for both the main carriageway and shoulder.
 - The project includes reblocking of dilapidated concrete pavement.
 - Inclusion of 206 (1) Polymer Stabilized Subbase/Base/Surface Course 250mm thick as base stabilizer since polymers are used to strengthen the soil or improve the base/subbase, making them relevant in new pavement proposals—especially since this is an N1 road, thus, requiring high load-bearing capacity.
 - The project also includes miscellaneous structures such as warning signs, regulatory signs, traffic instruction signs and Reflectorized Thermoplastic pavement markings (yellow and white).

 The adjustment in the station limit was made to prioritize sections necessitating Preventive Maintenance: Asphalt Overlay and to synchronize with the decrease in the physical target. (Please see attached Straight-Line Diagram)

The derived unit cost is based on approved Detailed Unit Price Analysis (DUPA) and Program of Work

(POW).

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).

Based on our evaluation, the submitted request for project modification is in order, hence, it is respectfully recommended to the Undersecretary for his consideration and approval.
