Justifications provided by the requesting Implementing Office:

Decrease in physical target for CW1 – Construction of Drainage Structure from **1,040.00 Lineal meters** to **645.50 Lineal meters** due to the following:

- Unit costs for CW1 increased due to increasing Prices of Construction Materials and Equipment Rental Rates Utilized for Infrastructure Projects.
- Reduced station limit based on the structures necessary on the field.
- Provision of 6.10m width carriageway, 0.23m thick with Curb and Gutter (Cast in place).
- Provision of Slope Protection Structures (Stone Masonry & Hand-Laid Rock Embankment) on some part to protect roads and drainage.

Approved Program of Works (POW), Detailed Unit Price Analysis (DUPA), Detailed Engineering Design (DED), Certificate of Availability of Funds (CAF), BP 202, Geotagged Photos, Certificate of Reasonableness of Cost Estimate, Styaight-Line Diagram and GIS Map.
