Justifications provided by the requesting Implementing Office:

- 1. Decrease in physical target for CW1 Construction of Drainage Structure from 453.00 Lineal meters to 350.00 Lineal meters due to the following:
 - Unit costs for CW1 increased due to increasing Prices of Construction Materials and Equipment Rental Rates Utilized for Infrastructure Projects.
 - Reduced station limit based on the structures necessary on the field.
 - Provision of 1.50m width shoulder, 0.15m thick on one side.
 - Provision of Slope Protection Structures (Stone Masonry & Rubble Concrete) on some part to protect roads and drainage.
