

- Decrease in physical target from 5.98 Lane km to 4.162 Lane km and change in end station limits from K0174+174 -K0174+928, K0175+047 K0175+596, K0175+756 K0176+140, K0176+320 K0177+617 to K0174+174.00 K0174+928.00, K0175+047.00-K0175+596.00, K0175+756.00 K0176+140.00, K0176+320.00 K0176+714.00 due to the following:
 - The road design requires the inclusion of Item 311(1)a 0.15m thick PCCP for 2.0m wide paved shoulder at stations with RCPC, retaining walls, lined canal, and slope protection in accordance to DGCS 2015 Volume 4.
- 2. Introduction of Item 404(1)a Reinforcing Steel Grade 40, Item 404(1)b Reinforcing Steel Grade 60, and Item 405(1)a3 Structural Concrete 20.68 Mpa due to the design of the proposed widened road necessitates the construction of retaining walls, lined canal and slope protection to address the inherent slope instability and to provide a controlled pathway for water. Retaining walls and slope protection structures will be utilized to provide the necessary structural support, effectively preventing soil slippage and collapse along the widened road. Also, lined canals prevent roadway damage by efficiently channeling runoff away, especially crucial during heavy rainfall.
- The design of the road also requires the inclusion of Item 603(3)a1 Metal Guardrail (Metal beam) including Post to enhance road safety by acting as physical barriers, to mitigate vehicle excursions and reduce the risk of severe accidents.
