Justification:

- Increase in physical target from 6.012 lane km to 6.854 lane km in view of exclusion of K0306 + 468.50 to K0306 + 677 in as much as this portion was newly overlaid in FY 2024 and inclusion of K0301 + 550 to K0301 + 942.70.
- Decrease in unit cost is due to the decrease in the thickness of item 201(1) – Aggregate Base Course from 200mm to 100mm thick in view of the usage of 250mm thick Polymer Stabilized Sub-Base Course based from the approved DED, hereby compensating for the increase in physical target from 6.012 lane km to 6.854 lane km.
- The derived unit cost is based on approved Detailed Unit Price Analysis (DUPA) and Program of Work (POW).

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No
