**Justification:**

- The increase in the unit cost/decrease in the physical target of CW1 – Preventive Maintenance of Road: Asphalt Overlay from 0.910 lane-km to 0.856 lane-km is due to:
  - Inclusion of additional Aggregate Base Course and Bituminous Prime Coat – MC – Cut-Back Asphalt Grade 70 for sections with existing granular base surface particularly at K0304 + 245 – K0304 + 546.30.
  - The project will utilize 100mm thk Asphalt Overlay (2-layer/50mm thick) for both the main carriageway and shoulder.
  - Asphalt overlaying of shoulders with widths varying from 0.30m to 0.50m.
- The project also includes miscellaneous structures such as warnings signs, regulatory signs, and Reflectorized Thermoplastic pavement markings (yellow and white).
- The adjustment in the station limits was made to prioritize sections necessitating preventive maintenance measures and to synchronize with the decrease in physical target. (Please see attached Straight Line Diagram).



Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).

Based on our evaluation, the submitted request for project modification is in order, hence, it is respectfully recommended to the Undersecretary for his consideration and approval.
