Justifications based on the attachment of the Implementing Office:

• **Deletion of the Word "Completion"**

The term "Completion" is proposed to be removed from the project title as the additional allocation provided for the project is insufficient to fully complete the entire scope of works originally envisioned. Retaining the word may create misleading expectations regarding the project's deliverables relative to the available funding.

• **Correction of the Street Name**

The project title is proposed to be updated to reflect the correct and official street name, changing "Agham Road" to "Senator Miriam P. Defensor-Santiago Avenue," in accordance with Department Order No. 150, series of 2023, entitled "Renaming Agham Road under the Jurisdiction of Quezon City 1st District Engineering Office (DEO) and BIR Road under the Jurisdiction of Quezon City 2nd DEO in Quezon City, National Capital Region to Senator Miriam

P. Defensor-Santiago Avenue." This correction ensures compliance with updated government issuances and geographical designations.


- **Ensuring Precision and Consistency with the Project Implementation Plan**
The revision aims to make the project title more precise and aligned with the current project implementation plan, thereby promoting clarity in project identification, documentation, coordination, monitoring, and reporting.





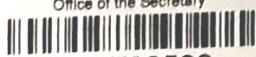
