Justifications provided by the requesting Implementing Office:

- The original project title/description was revised from K0036 + 150 K0036 + 860 to K0037 + 739
 K0037 + 1036, K0038 + 447 K0038 + 725, K0041 + 680 K0041 + 806 to avoid overlap and duplication with same project listed under FY 2024 General Appropriations Act (GAA).
- Physical target was revised from 2.84 lane km to 2.804 lane km for Preventive Maintenance:
 Asphalt overlay as first component and decreased from 440 to 412 lineal meters of Drainage
 Construction as second component. Therefore, unit cost will be slightly increased but still found
 reasonable due to changes in component length and introduction of the new type of work. The cost
 estimates of all items of work were based on CMPD of 1st Quarter, 2025.
- The slight reduction in asphalt overlay was based on original project length since the original length was 710 m and new project length is now changed to 701 meters as these station limits were validated and checked on site and which were deemed necessary for new asphalt overlay. These new station limits were also validated from RBIA data and Official Road Condition data which were
