Justification:

- Decrease in unit cost/Increase in physical target/Decrease in the unit cost based on the validated/approved Detailed Unit Price Analysis (DUPA) and Program of Works (POW) due to:
 - Design for asphalt overlay is 50mm which includes removal and reconstruction of damaged pavement (area=13,703.18 sq. m.) prior overlaying using Portland Cement Concrete Pavement (PCCP) of 14-day concrete (280mm thk).

- The project involves removal of actual structures/obstruction (50mm thick ACP = 284.08 sq. m.), surplus common excavation with a total volume of 3,151.73 cu. m., and subgrade preparation (common material) with a total area of 13,703.18 sq. m.
- The addition of miscellaneous structures such as application of reflectorized thermoplastic pavement markings and paving fabric for road safety features.
- Attached are the following supporting documents: Approved Program of Works (POW), Approved Plan, BP Form 202, Certificate of Availability of Funds (CAF), Certificate of Reasonableness of Cost Estimate, Geotagged Photos, and GIS Map of the Proposed Project Work Location.
