

Justification:

- Change/Correction in the project title/description from "Construction of Lake Mainit Circumferential Road Bypass Road to Wind Power **Butuan City Surigao Norte**" to "Construction of Lake Mainit Circumferential Road Bypass Road to Wind Power **Surigao del Norte**" due to omission of the phrase "Butuan City". This correction is necessary because Butuan City is not located in the Province of Surigao del Norte; it is situated in the Province of Agusan del Norte. The omission of "Butuan City" is essential to prevent confusion of its geographical location, as the project is actually located in Surigao del Norte (see attached Location Map).
- Also, corrected the word "**Surigao Norte**" to its appropriate Province Name: "**Surigao del Norte**" per REPUBLIC ACT No. 2786, S. 1960 - *An Act to Create the Provinces of Surigao del Norte and Surigao del Sur*.
- The project is a continuing project from FY 2022 to FY 2024, see attached multi year investment scheme and targets summary.
- The physical target and unit cost remain the same.
- Attached are the following supporting documents: Approved Program of Works (POW), Approved Plan, BP Form 202, Certificate of Availability of Funds (CAF), Geotagged Photos, Straight Line Diagram, and GIS Map.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
