- Change/Correction in the project title/description from "Construction of Jiabong -San Isidro River Control Project, Kitcharao, Agusan del Norte" to "Construction of Jaliobong-San Isidro River Control Project, Kitcharao, Agusan del Norte". The correction from "Jiabong" to "Jaliobong" is necessary because "Jaliobong" accurately refers to the specific section of the project that urgently requires flood control structures to prevent bank erosions. The project name should reflect its true geographical scope, which spans from Barangay Jaliobong to Barangay San Isidro in the municipality of Kitcharao, Agusan del Norte. See attached certification from LGU.
- The current project name is misleading because "Jiabong" does not exist within the municipality of Kitcharao, Agusan del Norte, nor is it found in any adjacent municipalities. This error could cause confusion and miscommunication regarding the project's location and intended beneficiaries. Correcting the project name to "Jaliobong" ensures clarity and accuracy in identifying the project's scope and location, thus facilitating better understanding and support for its objectives.
- The physical target and the unit cost remain the same.
- Attached are the following supporting documents: Approved Program of Works (POW), Approved Plan, BP Form 202, Certificate of Availability of Funds (CAF), Geotagged Photos, Straight Line Diagram, and GIS Map.
