With the scorecard as its checklist, the Corporate Planning & Management Division (CPMD) recently conducted a workshop on the 2018 2nd Level Performance Governance System (PGS) Scorecard Updating last February 12, 2019. The workshop provided the Regional PGS coordinators the guidelines in accomplishing the PGS 2018 Summary Forms that will determine the accomplishments of DPWH offices to be reflected in the scorecard.

The workshop was spearheaded by the PGS Committee Chairperson, Undersecretary Ma. Catalina E. Cabral and opened the one-day activity with the message of collaboration and unity. That through identifying and owning of targets, the Department's over-all PGS performance can only be realized through the collective accomplishment of its unit offices, particularly the Implementing Offices. That each kilometer of accomplished road which contributes to the goals of the DPWH strategy, constitutes the success of the PGS as a strategy management tool and ultimately, prepares the Department to its destination of KONKRETO 2022.

Further, the CPMD staff served as resource speakers and facilitators in the said workshop attended by the sixteen (16) RO-PGS Coordinators. This is the 2nd workshop conducted by CPMD regarding the PGS Scorecard since November 2018. Meanwhile, Engr. Jake Bonn Dumpasan, Officer-in-Charge of CPMD, also shared some vital information regarding the matter and some high-impact project accomplishments of the Central Office before his concluding message.
