

The committee shall assume the functions in accordance with the Rule IV, Section 8 (c) (7) and Section 9 of the IRR for Section 2, 3 and 4 of the Republic Act No. 7192" approved under NEDA Board Resolution No. 35, Series of 1992.

The Environmental and Social Safeguards Division (ESSD) headed by the Planning Service Director shall serve as the Technical Working Group (TWG) to assist the Committee in the discharge of its functions.

This order shall take effect immediately and supersedes the following issuances:
