**Justification:**

This modification is sought due to the following reasons:

1. Typographical error. The word "including bridge" should not form part of the project description, the type of work to be done should be "construction of concrete road" considering that there is a need to construct the road first to serve as an access prior to the construction of the bridge;
2. The unit cost value of the construction of concrete road is high considering that there is a need to provide large amount of embankment as foundation fill in order to level the elevation of the road;
3. The inclusion of ROW acquisition for the payment of the affected properties; and
4. The need to provide road slope structure to protect the road from erosion.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
