MODIFIED ENHANCED COMMUNITY QUARANTINE OVER THE NATIONAL CAPITAL REGION AND THE PROVINCES OF LAGUNA, CAVITE, RIZAL, AND BULACAN UNTIL 18 AUGUST 2020

DATE

3 August 2020

Pursuant to the declaration of the President last 02 August 2020, the National Capital Region and the provinces of Laguna, Cavite, Rizal, and Bulacan shall be placed under a modified enhanced community quarantine (MECQ) effective 12:01 a.m. of 04 August 2020 until 11:59 p.m. of 18 August 2020.

In view thereof, all heads of departments, agencies, offices and instrumentalities of the government, including the Philippine National Police, Armed Forces of the Philippines and the Philippine Coast Guard, GOCCs, GFIs, SUCs and LGUs are hereby directed to strictly observe and implement the applicable guidelines provided under the *Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines*, as amended, issued by the IATF, and other relevant issuances.
