To provide for a more efficient, competitive, and transparent process in the procurement of consulting services for locally-funded infrastructure projects through competitive bidding in accordance with the provisions of Republic Act No. 9184 and its Implementing Rules and Regulations, the Bids and Awards Committee (BAC) for Consultancy Services and other offices/personnel of this Department shall observe the following guidelines in the shortlisting of consultants and evaluation of bids for such consulting services.

1. Shortlisting of Consultants

1.1 Criteria for Shortlisting

The following criteria and their corresponding maximum points shall be used in the shortlisting of consultants:

Experience of the Firm The firm, or its proposed Project Manager/Team Leader for the services to be procured, must have satisfactorily completed one services contract similar to, and with the following cost as a percentage of the Approved Budget for the Contract (ABC) of, the services to be procured.	35

If the firm or its proposed Project Manager/Team Leader has not completed any similar contract, it shall be disqualified.

1.2 Passing Total Score

To be eligible for inclusion in the short list, a consultant must obtain a Minimum or Passing Total Score of 60%.

2. Evaluation of Consultants' Bids/Proposals

2.1 Quality Cost Based Evaluation (QCBE): Passing Technical Scores and Quality-Cost Weights

The following Minimum or Passing Technical Scores and Weights of Quality and Cost shall be adopted in the QCBE process.

2.2 Quality Based Evaluation (QBE): Passing Technical Score

The Minimum or Passing Technical Score in the QBE process shall be 75%.
