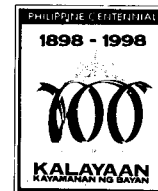

SUBJECT: Amendments to Department Order No. 73, Series of 1998, re: Accreditation and Assignment of DPWH Project Engineers and Inspectors, and Department Order No. 209, Series of 1998, re: 1st Partial List of Accredited Project Engineers and Inspectors

In view of the merit of the request for reconsideration of the contractual engineers from the different Project Management Offices (PMOs) of this Department relative to the accreditation of field engineers, the classification of field engineers under Item 2.0 of Department Order No. 73, Series of 1998, is hereby amended, to read as follows:

“The classification of field engineers shall be as follows:

- a. The designation of Project Engineer shall be given to those holding permanent plantilla and contractual items, with classification ranks determined as follows:

Total Rating	Classification
76 & above	Project Engineer III
71 - 75	Project Engineer II
61 - 70	Project Engineer I

- b. The designation of Project Inspector shall be given to those holding casual/daily item, with classification ranks determined as follows:

Total Rating	Classification
71 & above	Project Inspector II
61 - 70	Project Inspector I

Engineers holding permanent plantilla and contractual items who fail to be accredited as Project Engineers (PE) may be designated as Project Inspectors (PI), provided their total rating is not less than 50 points”.

As such, the following accredited field engineers listed under Department Order No. 209, Series of 1998, are hereby given new classification ranks indicated opposite their names:
