SUBJECT: Additional Functions, Responsibilities and Authorities of Undersecretary Romulo M. del Rosario and other DPWH Officials

As required by the exigencies of the service, the following additional assignments and authorities are hereby given/delegated to the DPWH officials hereunder named:

1. UNDERSECRETARY ROMULO M. DEL ROSARIO

- 1.1 Undersecretary for Field Operations "A" (FOA) as grouped and configured under Department Order No. 130, dated 30 May 1991 and as modified under Department Order No. 201, dated 26 November 1992;
- 1.2 Undersecretary for Allied Services related to Foreign-assisted projects with administrative and technical supervision over all Central Office Project Management Offices;
- 1.3 Chairman, Central Office Prequalification, Bidding, and Awards Committee (PBACs) for civil works and for construction equipment/materials/supplies contracts of projects under FOA; and
- 1.4 Chairman, Central Office Prequalification, Evaluation and Awards Committee (PEAC) for consulting services for projects under FOA.

Excluded from the above-enumerated additional functions and responsibilities are those pertaining to, and under the operational jurisdiction of, the Project Management Office for Mt. Pinatubo Rehabilitation Projects, and Rehabilitation Projects funded under the Earthquake Rehabilitation Fund.

2. DIRECTOR LEONARDO NUNEZ

The operational/administrative supervision and the delegated authorities presently exercised by Director Leonardo Nunez in his capacity as Head of the DPWH Central Project Implementation Unit for the prosecution of Rehabilitation Projects funded under the Earthquake

Rehabilitation Fund are hereby enlarged and increased to the level of supervision and the limit of authority presently exercised by/delegated to the Undersecretaries for Field Operations and the Undersecretary for Allied Services/DPWH Action Officer of the Presidential Task Force on the rehabilitation of areas affected by the July 16, 1990 earthquake, under existing or subsequent Department issuances.

Under and by virtue of these additional delegated authorities, and with respect to the implementation of earthquake rehabilitation projects, Director Nunez shall be directly under the supervision of the Secretary of Public and Highways.

3. PROJECT DIRECTOR FLORANTE SORIQUEZ

The current level of substantive and administrative functions and authorities of the Project Director, Project Management Office for Mt. Pinatubo Rehabilitation Projects is hereby increased to the level and scope of the functions and authorities presently or as may hereafter be assigned/delegated to the Undersecretary for the Mt. Pinatubo Rehabilitation Program.

By virtue of this additional delegation of authority, Project Director Soriquez shall be under the direct supervision of the Secretary of Public Works and Highways.

All Department Orders/issuances or parts thereof inconsistent with the provisions of this Order are hereby superseded or accordingly modified.

This Department Order shall take effect immediately.
