SUBJECT: CREATION OF A TASK FORCE
FOR THE STUDY OF THE CAUSES
OF FLOODING AND APPROPRIATE
FLOOD CONTROL PROTECTION
MEASURES FOR LOW-LYING AREAS
AT OBANDO, BULACAN AND AT
VALENZUELA, MALABON, NAVOTAS
AND TONDO, METRO-MANILA

As a result of the public hearing held on August 1, 1984, concerning the recurrent flooding of low-lying areas at Obando, Bulacan and at Valenzuela, Malabon, Navotas and Tondo, Metro-Manila, it was decided that in order to minimize damage by the flooding to public and private property and hazards to life, a Task Force shall be created to undertake a thorough study of the causes thereof and appropriate flood protection therefor.
