SUBJECT: Reorganization of the Membership

In view of the appointment of Undersecretary Juanito N. Ferrer as Secretary of the Department of Local Government and to provide for the orderly transition of responsibilities, the membership of the PBAC's for Infrastructure Projects, Procurement of Construction Materials and Supplies and Procurement of Construction/Maintenance Equipment are hereby reorganized as follows:

1. PBAC FOR INFRASTRUCTURE PROJECTS

This Committee shall be responsible for the bidding, pre/postqualification of prospective contractors and award of infrastructure contracts advertised for bidding in the Central Office. The Chairman is authorized to sign Invitation to Bids, but all Resolutions of Awards shall be subject to approval by the Secretary.

2. PBAC FOR PROCUREMENT OF CONSTRUCTION MATERIALS AND SUPPLIES

Invitations to Bid for delivery of construction materials and supplies, but all proposed awards shall be subject to approval by the Secretary prior to the issuance of the purchase order.

Except as otherwise provided in Ministry Order No. 62 dated December 5, 1986, procurement of construction materials and supplies needed by the difference offices of the Department Proper, including Project Management Office, within Metro Manila, shall be made thru this Committee.

3. PBAC FOR PROCUREMENT OF CONSTRUCTION/MAINTENANCE EQUIPMENT

Under this reorganization the existing PBAC Secretariat shall serve as the technical support staff of the above PBACs.
