In accordance with the provisions of Section 2.0 of DBM Circular Letter No. 2001-5 dated 01 March 2001 with the subject "March 2001 Obligational Authority", the grant of the DPWH employees uniform allowance is hereby authorized.

Pursuant to the said circular, the current year uniform allowance in the amount of P3,000.00 will be given in cash to each DPWH employee who shall have the option to procure new sets of uniforms using the same/similar materials and design of uniforms procured in C.Y. 2000.

Payrolls of offices shall be prepared and processed immediately, subject to availability of funds and existing accounting and auditing rules and regulations.

This Order shall take effect immediately.

CIRCULAR LETTER

NO. 2001 - 5

TO : Heads of Departments/Agencies/State Universities and Colleges and Other Offices of the National Government; Budget Officers; Heads of Accounting Units and All Others Concerned

SUBJECT: March 2001 Obligational Authority

1.0 For the month of March 2001, all agencies are hereby authorized to obligate an amount equivalent to one twelfth (1/12) of their approved budget levels as determined by DBM, under the FY 2000 General Appropriations Act (GAA), as reenacted, for the following:

- 1.1 Personal Services - Including the one month requirement of the 10% salary increase implemented in CY 2000, net of the requirements for Productivity Incentive Benefits and Clothing and Uniform Allowance;
- 1.2 Maintenance and Other Operating Expenses; and
- 1.3 Capital Outlays.

2.0 Agencies are also authorized to obligate the requirements for ~~Productivity Incentive Benefits~~ computed equivalent to an average of P2,000 per employee and the ~~Clothing and Uniform Allowance~~ at P3,000 per employee.

3.0 Authority is also issued to obligate an amount equivalent to one-twelfth (1/12) of Automatic Appropriations of the following:

- 3.1 Retirement & Life Insurance Premiums (equivalent to 12% of the salaries component under Item 1.1); and
- 3.2 Special Account in the General Fund programmed in the FY 2001 NEP.

4.0 Obligations to be incurred pursuant to this Circular Letter shall be treated as overdraft in appropriations and shall be adjusted once the allotment chargeable against the 2001 GAA is received. The rules and regulations pertinent to the appropriate accounting entries are prescribed under COA Circular 96-002 dated February 27, 1996.
